Regular Commission Meeting Minutes
June 20, 2023

I. CALL TO ORDER

Commissioner Taylor called to order the meeting of the Port of Shelton Commission at 2:00 PM on June 20, 2023.

The following persons were present: Commissioner Buck; Commissioner Patterson; Tricia Needham, Finance Director; Jan Fancher, Port Auditor and CPA; and Dale Elmund (via Zoom).

V. APPROVE MEETING MINUTES

Meeting Minutes from the regular meeting on May 16, 2023 were approved as presented.

VI. CHECK CONTROL

Commissioner Patterson presented the June 6, 2023 Check Control Report. She reported payroll and payroll liability electronic payments dated May 19, 2023 and June 5, 2023 in the amount of \$78,992.37. Accounts payable check numbers 32136 through 32154 dated June 6, 2023 in the amount of \$63,445.62, and accounts payable electronic payments dated May 22, 2023 through June 6, 2023, including one voided eft dated May 30, 2023, in the amount of \$19,737.42 for a total accounts payable of \$83,183.04. The total General Fund checks and electronic payments in the amount of \$162,175.41 have been approved and accepted as presented.

Commissioner Patterson presented the June 20, 2023 Check Control Report. She reported payroll and payroll liability electronic payments dated June 20, 2023 in the amount of \$35,152.66. Accounts payable check numbers 32155 through 32168 dated June 20, 2023 in the amount of \$25,588.93, and accounts payable electronic payments dated June 2, 2023 through June 20, 2023 in the amount of \$3,208.89 for a total accounts payable of \$28,797.82. The total General Fund checks and electronic payments in the amount of \$63,950.48 have been approved and accepted as presented.


The regular commission meeting resumed at 2:33 p.m.
