I. CALL TO ORDER

Commissioner Taylor called to order the regular meeting of the Port of Shelton Commission at 2:00 PM on June 18, 2024.

V. APPROVE MEETING MINUTES

VI. CHECK CONTROL

- The Port submitted for the EDA funding last week for the equipment and design for a substation serving Port of Shelton property and beyond.
